**Chinese Government Scholarship**

**High-Level Postgraduate Program**

The 'High-Level Postgraduate Program' is a sub-program of the Chinese Government Scholarship Program. The program is based on the principles of "individual application, institutional recommendation, expert assessment and selection on the basis of merit", and selects international students with excellent academic background, outstanding professional ability and future development potential. A brief description of the program is as follows:

## **I. Target students:**

Full-time master's and doctoral students for the September intake, 2026.

## **II. Majors:**

For specific information about the majors, please refer to the attachment 《附件 1-中国矿业大学 2026-2027 学年 CSC 高水平研究生项目招生专业 Available Majors for 2026-2027 CSC High Level Postgraduate Program》.

## **III. Eligibility:**

- Be a citizen of a country other than the People's Republic of China and be in good health both mentally and physically;
- Be a bachelor's degree holder under the age of 35 when applying for master's programs;

- Be a master's degree holder under the age of 40 when applying for doctoral programs;
- Have acquired the Chinese proficiency of HSK Level 4 when applying for Chinese taught master's or doctoral programs;
- Meet the admission requirements of the applied universities in terms of academic ability, language proficiency and other relevant criteria.

#### **IV. Scholarship:**

The specific details of scholarship are subject to the information published on the "CSC Study in China" website ([www.campuschina.org](http://www.campuschina.org)).

#### **V. Application Documents:**

**1. Copy of Passport Home Page.** If the validity of the applicant's current passport does not meet the requirement (meaning the passport expires before September 2026), please apply for a new passport before submitting the application.

**2. Notarized highest diploma.** Prospective diploma winners must submit official proof of student status by their current school. Documents in languages other than Chinese or English must be attached with notarized Chinese or English translations.

**3. Academic transcripts (from the undergraduate program onwards).** Copies of academic records from first to last semester during the undergraduate, graduate (if any), and doctoral programs (if any) shall be provided. These transcripts shall be issued and sealed by the attending university's academic affairs office, graduate school, or student management department. They can be in Chinese or English, but must be attached with notarized English translations if they are in foreign languages other than English.

**4. Language qualification certificates.** Applicants for Chinese-taught programs must submit a valid HSK 4 report. Applicants for English-taught programs shall provide IELTS  $\geq$  6.0 or TOEFL  $\geq$  85 or Duolingo  $\geq$  110 reports.

**5. Pre-admission Notice.** Applicants shall submit the application via the CSC system first. A pre-admission notice will be sent to the proposed candidates upon completion of all review procedures.

**6. A study plan proposal.** A study plan written in Chinese or English shall contain more than 1,000 characters or words; the proposal of a doctoral student shall be signed by the applicant's Chinese supervisor.

**7. Recommendation letters.** Two letters of recommendation (written only in Chinese or English) from professors or associate professors shall be submitted. These letters shall describe the applicant's objectives of learning in China, comprehensive abilities, and evaluation of future growth, as well as the cooperation between the supervisors or the exchange between universities both in China and abroad.

**8. Acceptance Letter.** (Download format 《附件 2-中国矿业大学国际学生招生推荐表、导师接收函 Acceptance Letter Format》). Applicants for a Master's or PhD degree are advised to provide a letter of acceptance from a professor in our university. The contacts of supervisors can be found from 《附件 3- 中国矿业大学导师联系方式 Supervisors' Contacts》 .

**9. A photocopy of the Foreigner Physical Examination Form** completed in English (the original copy shall be kept by the applicant). The form is designed by the Chinese quarantine authority and can be obtained from the dispatching authority. The physical examinations must cover all the items listed in the Foreigner Physical Examination Form. Incomplete records or those without the signature of the attending physician, the official stamp of the hospital, or a sealed photograph of the

applicants are invalid. Please select the appropriate time to take a physical examination as the result is valid for only 6 months.

**10. Non-criminal record report.** The applicant shall submit a valid certificate of Non-Criminal Record issued by the local public security authority, usually be issued within 6 months prior to the submission date of the application.

11. Applicants under the age of 18 should submit the valid documents of their legal guardians in China.

**Reminder:** Uploaded supporting documents must be clear, authentic and valid. Applicants are recommended to use a professional device to scan the relevant documents. Applicants shall bear the consequences caused by unclear or unidentifiable uploaded materials.

## **VI. Application Process:**

### **1. Application Online**

- (1) Visit "CSC Study in China" website and click "Scholarship Application for Students" at <http://www.campuschina.org>
- (2) Input Personal Details, and select Program Category "Type B". The Agency Number of China University of Mining and Technology is **10290**.
- (3) Move on to the section of "Language Proficiency and Study Plan" and upload "Supporting Documents" as requested, then click "Submit" to complete the application.
- (4) Once submitted, amendments cannot be made on "Personal Details" and "Application Information". Before the application is processed by the processing authorities, applicants can revoke the submitted application by clicking "Withdraw" and edit the application. After revoking the application, applicants must submit it again after re-editing, or the

application will not be processed. Once the application is processed, the application cannot be revoked.

(5) Click “Print the Application Form” and download the form.

## **2. Exam Arrangement**

After the applicant's information is approved, CUMT will notify the applicant by email about the exam or interview. Please make sure your email address is correct and check your email regularly so that do not to miss the notice of exam arrangement.

## **3. Admission**

Applicants can check the admission results in the "Chinese Government Scholarship Information System". **Applicants are not currently required to apply on the university's application system.** Successful CSC scholarship recipients will receive separate notification from the university regarding the procedure for completing their information registration in the university system. Applicants who are not awarded the CSC scholarship but still wish to enroll at our institution may apply through the university system for self-funded admission or university scholarship opportunities.
